## Requirements and Procedures

### I. Deadline

Application must be received before April 15, 2017.

### II. Eligibility

- Applicant must be a minority identified by the U.S. Census Bureau as follows: Black/African American, Asian or Pacific Islander, Hispanic, American Indian, Alaskan Native, or Female.
- Applicant must be a full-time or part-time student enrolled in real estate related courses in real estate or a related field within a U.S. degree granting college/university or junior college.
- Applicant must have a current cumulative grade point average of no less than 2.5 on a 4.0 scale.
- Applicant must have financial need.
- Scholarship award must be used in the same calendar year as awarded.

### III. Required

- An official student transcript for all college work completed to date.
- A 500-word written essay addressing the applicant's financial need and stating why applicant should be awarded the scholarship.
- Two letters of recommendation from previous employers and/or college professors.
- An attestation that the scholarship will be applied toward tuition, as stated in the application.
- Optional: Applicants are asked to include a head and shoulders photograph as scholarship recipients may be profiled in Appraisal Institute Education Trust and/or Appraisal Institute electronic and/or print media.

### IV. Awards

- \$1,000

### V. Award Process

- Any awards granted will be paid directly to the Academic Institution identified on the application and may be used for tuition only.

### VI. Application Process

- Complete the enclosed application.
- Attach any supporting documents required in the "III. Required" (i.e. transcript and resume)
- Have the Academic Institution's financial assistance officer complete the designated sections.
- All portions of the application must be completed and all information supplied must be accurate, otherwise the application will not be eligible for consideration.
