Bayville's David Bradley, MAI, SRA, Honored as Appraisal Institute's 'Volunteer of Distinction'

CHICAGO (June 2, 2010) – David Bradley, MAI, SRA, of Bayville, NY, was recognized today as the Appraisal Institute's June "Volunteer of Distinction" for Region IV.

The Appraisal Institute is the nation's largest organization of real estate appraisers; Region IV includes Connecticut, Maine, Massachusetts, New Hampshire, New York, Rhode Island, Vermont and Eastern Canada. Bradley is a member of the Appraisal Institute's Long Island Chapter.

"David Bradley is an example of the outstanding individuals who belong to the Appraisal Institute," said Leslie P. Sellers, MAI, SRA, Appraisal Institute president. "We're proud of the contributions David and all our members make to our organization, to the real estate valuation profession and to the communities where they work and live."

Bradley has been a member of the Appraisal Institute for 37 years. His service to the Appraisal Institute includes serving as chair of the Long Island Chapter's Professional Practice Committee and as a chair of its Admission, Education and Seminar Committee. A past president of the Long Island Chapter, he has taught Appraisal Institute courses around the world as an instructor and also has served on the Appraisal Institute's national committees for education and ethics administration.

Bradley has been involved in the real estate valuation profession for nearly 40 years. His service to the profession includes authoring several articles for The Appraisal Journal and serving as a key contributor to the publication of The Appraisal of Real Estate, 11th edition. In 1990, Bradley's contribution, "The Laws of Real Estate Dynamics," earned him The Appraisal Journal's prestigious Armstrong Award for that year's best original article. He has been certified as a general real estate appraiser by the state of New York and has been president of Bradley and Co. Appraisers, Inc since 1975.

In his community, Bradley has been recognized for his joint service to the real estate profession and the community. In 1993 he was the recipient of the Long Island Chapter Recognition Award. In 2009, he was honored with the Long Island Chapter's Lifetime Achievement Award.

Bradley, 75, joined one of AI's predecessor organizations in 1973 and earned his SRA designation in 1976 and his MAI designation in 1978. He graduated from the Massachusetts Institute of Technology with a degree in aeronautical engineering.
