He received the President's Award in 2001 for participation on the Commercial Database Committee and received the James H. Pritchett Memorial Award in 2003 for overall contribution to the Appraisal Institute.

Having received his MAI designation from the Appraisal Institute in 1978, Shiplett is managing director of Grubb & Ellis/Landauer Valuation Service in Charlotte. For seven years, he was owner of R.W. Shiplett & Associates. He is qualified as an expert witness in courts in North Carolina, South Carolina and Florida.
