## Livingston's Diane Christiana Honored as Appraisal Institute's 'Volunteer of Distinction'

She also is a past member of the Roseland Board of Education and the Roseland Junior Women's Club. She was voted Volunteer of the Year in 2001 for the Borough of Roseland and was named Municipal Official of the Year in 2007 for Essex County, receiving a lifetime achievement award from the county last year.

Christiana, 48, has worked in the real estate valuation profession for seven years and currently is senior appraiser at Appraisal Consultants Corp. in Livingston, N.J. She earned her bachelor's degree in

business administration from Dowling College. She and her husband, Dr. William Christiana, have two sons, Andrew and Matthew.
