- Practicing Designated Member:** Designated Member in good standing who provides Service(s) as defined by the Code of Professional Ethics. Some Practicing Designated Members may also hold the status of Past President Designated Member, Life Designated Member or Semi-Retired Designated Member.
- Non-Practicing Designated Member:** Designated Member in good standing who does not provide any Service(s) as defined by the Code of Professional Ethics. Some Non-Practicing Designated Members may also hold the status of Temporarily Non-Practicing Designated Member, Retired Designated Member, Past President Designated Member, or Life Designated Member.
- Practicing Life Designated Member:** Designated Member in good standing who has held membership in the Appraisal Institute or its predecessor organizations continuously for at least 40 years and is current in the payment of full membership dues.
- Practicing Semi-Retired Designated Member:** Designated Member in good standing who is at least sixty (60) years of age and earns no more than \$25,000 in each calendar year from Services(s) as defined by the Code of Professional Ethics. The Board of Directors shall establish such dollar amount from time to time.
- Non-Practicing Retired Designated Member:** Designated Member in good standing who is at least sixty (60) years of age and who does not provide any Service(s) as defined by the Code of Professional Ethics.
- Non-Practicing Life Designated Member:** Designated Member in good standing who has held membership in the Appraisal Institute or its predecessor organizations continuously for at least 40 years and is current in the payment of full membership dues, and who does not provide any Service(s) as defined by the Code of Professional Ethics.
- Temporarily Non-Practicing Designated Member:** Designated Member in good standing who is temporarily unavailable to provide any Service(s) as defined by the Code of Professional Ethics due to: (i) poor health or physical disability; (ii) family obligation or responsibility; (iii) military service; or (iv) other good cause shown.
