## **Laguna Beach's Orell C. Anderson Honored as Appraisal Institute's 'Volunteer of Distinction'**

He earned his bachelor's degree from Brigham Young University, master's degree from California State University Long Beach and Ph.D. from Fielding Graduate University.

Green Award for Journalistic Excellence and on the Environmental Litigation Committee of the American Bar Association Section of Litigation. On a volunteer basis with his church, he was Sunday school president, two-year missionary in Iceland, employment and welfare counselor and crisis prevention volunteer. He served on the City of Mission Viejo Library Committee, Santa Monica Public Art Board and Very Special Arts Board of Directors. He has volunteered with the Saddleback Women's Hospital, Veterans of Foreign Wars of the United States and the YMCA. He was born in Copenhagen, Denmark, is conversant in five languages and enjoys fly fishing, sculpture, skiing and Scandinavian Peninsula medieval literature. He is married to Franceskay Anderson; they have three children.
