Overview

Course Description

Whether you are an experienced appraiser who writes or reviews federal land acquisition appraisals or you are an appraiser interested in expanding your client base to include federal and state agencies and organizations, this course will show you how to apply the 6th edition of the Uniform Appraisal Standards for Federal Land Acquisitions in practice. An optional one-hour exam is included.
